INVITATION FOR BIDS FOR THE DESIGN AND CONSTRUCTION OF A CARPARK AND WALKWAY AT DEVELOPMENT HOUSE IN NDOLA (DBZ/HRPA/ONB/03/2017)

The Development Bank of Zambia (DBZ) is a development finance institution that provides competitively priced tailor-made financial and advisory solutions to viable local enterprises as a catalyst in economic development.

DBZ has made a provision in its budget towards the cost of **Design and Construction of a Car Park and Walkways** at its Development House in Ndola and intends to apply these funds to eligible payments under the Contract for which this Invitation for Bids (IFB) is issued.

DBZ now invites sealed bids from eligible Bidders for the **Design and Construction of a Car Park and Walkways** at its Development House in Ndola.

Bidding will be conducted using the Open National Bidding (ONB) procedures specified in the Public Procurement Act of 2008 and the Public Procurement Regulations of 2011, and is open to all Bidders eligible as defined in these Bidding Documents that have a valid NCC certificate in **Category B or C in Grade 5**.

Interested eligible bidders may obtain further information and inspect the Bidding Documents from Room 308, situated on the 3rd Floor, Development House, Corner of Cha Cha Cha and Katondo Roads, Lusaka between 8:00-17:00 hours during working days. Bidding Documents may be purchased by interested bidders from Room 314/317, 3rd Floor, Development House, Corner ChaChaCha and Katondo Roads, Lusaka, upon payment of a non-refundable fee of Five Hundred Kwacha (K500.00) in Cash or Bank Certified Cheque. Interested eligible bidders are invited to attend a **Mandatory Pre-Bid meeting and Site inspection on Friday, 10th March, 2017 at 10:00 hours**, Development House in Ndola along President Avenue.

All bids must be accompanied by a Bid Security of not less than 2% of the Bid Price.

Appropriately bound, sealed Bids bold labeled "**DESIGN AND CONSTRUCTION OF A CAR PARK AND WALKWAYS AT DEVELOPMENT HOUSE IN NDOLA**" must be deposited in the Tender Box situated at the Foyer, 5th Floor, Development House, Corner ChaChaCha and Katondo Roads, LUSAKA on or before **Friday, 24th March, 2017 at 10:00 hours** local time. **LATE BIDS WILL NOT BE ACCEPTED.**
