DESCRIPTION OF REQUIREMENTS

The United Nations Economic Commission for Africa (ECA) located in Addis Ababa, Ethiopia is seeking Expressions of Interest (EOIs) from qualified companies with the required expertise and experience, from all countries, for the review of Developed Design (pre-tender dossier) related to the "Main Building Works" of Africa Hall Renovation Project.

The scope of the review includes but not limited to assessment of all disciplines composing the design (namely: architecture/heritage, civil, structural, electro-mechanical); a gap analysis to assess whether there are any major design omissions, missing design data or design methodologies; comments log containing detailed observations for the original designer to review and respond; remarks to designers proposed course of action; a comprehensive final report including remarks, comments and advice based on the functional requirements included in the brief to ensure compliance with applicable codes and standards; and review of pre-tender cost estimate.

Request for Proposal (RFP) document will be issued to those companies that expressed interest.

1) Registering as a Vendor with the United Nations
