The Government of Cabo Verde is to finalize a co-financing program with ORIO (Government of the Netherlands) and OFID — OPEC FUND FOR INTERNATIONAL DEVELOPMENT a project in order to construct, develop and maintain a Cruise Vessels' Terminal, in Island of S. Vicente in the Cabo Verde, and intends to apply part of the proceeds for consulting services "Project Technical Assistance and Works Supervision Consultant for the Construction, Development and Maintenance of the Cruise Vessels Terminal in Mindelo — Employer's Representation".

The consulting services ("the Services") is to retain the services of a Consultant to assist the Government of Cabo Verde, through the Ministry of Maritime Economy, Ministry of Infrastructure and ENAPOR with the implementation of the above Project. The selected Consultant, called Employer's Representative (ER), shall provide Review Services and Update of Basic Technical Project, Basic Design of Cruise Destination Development Plan and Procurement Plan; Elaboration of Tender Documents; Tender Process Management and Evaluation; Project Management Support Services; Supervision of the Engineering Detailed Design

and Technical Auxiliary Studies; Environmental and Social Impact Management Services; and, Construction Supervision Services to MME/MIHOT/ENAPOR.

The Ministry of Maritime Economy, Ministry of Infrastructure and ENAPOR, now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services (Brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.).

The shortlisting criteria are: (i) Experience in Port Engineering Design; (ii) Experience in Hydraulic and Port Works Supervisions; (iii) Experience in Monitoring and Management Environmental Plans; (iv) Experience in Cruise Tourism Development; (v) Experience in Procurement of Works.

A firm that has been engaged by Ministry of Maritime Economy, Ministry of Infrastructure and ENAPOR and/or related institutions and/or enterprises to provide goods, works or services for a project, and any of its affiliates, shall be disqualified from providing consulting services related to those goods, works or services, as (including its Experts and Sub-consultants) or any of its Affiliates shall not be hired for any assignment that, by its nature, may be in conflict with another assignment of the Consultant for the same or for another Client.

Consultants may associate with other firms in the form of a joint venture or a subconsultancy to enhance their qualifications.
